The undersigned participant (or if the participant is a minor, such minor's undersigned parent or legal guardian both on behalf of itself and such minor) (collectively, "Releasor") in consideration of being provided the opportunity by Generations Christian Church, The Commons at Trinity, and the Trinity Commons Farmers Market, ("TCFM") to play, attend or otherwise participate in the recreational and promotional activities and the related activities offered as part of the Lightning Made and/or 'Lightning Community Hockey' event specified above (collectively, the "Event") at the host Facility specified above (together with each of its surrounding parking lots, field, and such other areas immediately adjacent thereto), voluntarily agrees that all the terms set forth in the Lightning Foundation, Inc and Lightning Hockey LP Acknowledgement and Release, which was signed by Releasor in order to participate in Event, also applies to TCFM, The Commons at Trinity, Generations Christian Church, and all of their respective parents, subsidiaries, affiliates and related persons or entities (collectively referred to as "TCMF"); and all their employees, volunteers, independent contractors, officers, directors, and members. I HAVE HAD SUFFICIENT TIME AND OPPORTUNITY TO REVIEW AND DISCUSS THIS RELEASE WITH AN ATTORNEY OF MY CHOICE AND I HAVE HAD ANY QUESTIONS ABOUT THIS RELEASE ANSWERED TO MY SATISFACTION.

NOTICE TO A MINOR CHILD'S NATURAL GUARDIAN

YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND RELEASEES HAVE THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

If the participant is under the age of 18: I am a parent (or legal guardian or the person having parental authority) of the minor who has signed this Release and I agree, on behalf of such minor and on my own behalf, that I and such minor will be bound by all the provisions contained herein. I represent and warrant that I am the parent or legal guardian of such minor, that I have the authority to enter into this Release on behalf of said minor and on my own behalf and that I have read this Release and fully understand its terms and their significance as applied to such minor and to me.
